ABOUT THE CLUB OF FUN AND REVENTIVE "ZHAIDARMAN"

1. General Provisions

- 1.1 Club of cheerful and resourceful "ZHAYDARMAN" (hereinafter referred to as KVN) is a voluntary association of students, youth and adults, focused on universal human values, developing tolerance, creativity, and acting.
- 1.2 KVN is created in accordance with the regulations on the youth organization Academy.
- 1.3 In its activities, KVN is guided by the Constitution of the Republic Kazakhstan, Law of the Republic of Kazakhstan On Education, Law "On state youth policy in the Republic of Kazakhstan", regulation "On the youth organization of the college", as well as these Regulations.
- 1.4 KVN members carry out their activities based on their aspirations, abilities and needs, if it does not contradict legislation of the Republic of Kazakhstan.
- 2. Goals and objectives of KVN

2.1 KVN goals:

- 2.1.1 development and support of the youth KVN movement;
- 2.1.2 implementation of youth policy;
- 2.1.3 attracting young people to active political and public life;
- 2.1.4 popularization of the KVN movement and promotion of the KVN team at the republican level.
- 2.1.5 formation among young people of an attitude towards an active life position, skills of socially responsible behavior, as well as promotion of the values of humanism and a healthy lifestyle.
- 2.2 To achieve these goals, the following tasks are solved:
- 2.2.1 development of the intellectual and creative abilities of young people through active artistic and aesthetic forms of activity;
- 2.2.2 formation of the need for self-realization and self-development;
- 2.2.3 creating an environment for creative communication between KVN participants;
- 2.2.4 patriotic education of youth;
- 2.2.5 expansion of friendly relations between educational institutions universities;
- 2.2.6 identifying the most proactive and creative individuals to attract them to the organization of KVN and other events:
- 2.2.7 popularization of the ideas of volunteering among students;

3. Areas of activity of KVN

- 3.1 Areas of activity are formed in accordance with the goals and objectives defined by these Regulations and the work plan of the Academy's youth organization.
- 3.2 The main activities of KVN are:
- 3.2.1 preparation of performances at KVN games;
- 3.2.2 regular participation of the team of the Academy of Logistics and Transport in KVN competitions at various levels;
- 3.2.3 participation in cultural and entertainment events of the Academy, including during state and national holidays;

- 3.2.4 preparation and training of junior students to participate in KVN games, education of the young generation.
- 3.2.5 creating conditions for self-realization for adolescent members of the organization through the use of their skills and abilities and the manifestation of abilities for the benefit of other people;
- 3.2.6 promotion of KVN among the youth of the Academy, through the Academy's social network.

4. Members of KVN. Rights and obligations

- 4.1 Members of KVN can be Academy students who voluntarily accept the ideas of the KVN movement and agree to implement them in their lives.
- 4.2 KVN members can unite into teams to participate in various games, tournaments, and festivals.
- 4.3 The rights and obligations of KVN members are based on the goals and objectives defined by these Regulations and the regulations of the youth organization of the Academy.

4.4 KVN members have the right:

- 4.4.1, in agreement with the management of the Academy, represent the university at games, tournaments, festivals of various levels;
- 4.4.2 create mechanisms for involving young people in the diverse activities of KVN;
- 4.4.3 make proposals regarding the activities of KVN and participate in their discussion and implementation;
- 4.4.4 receive information about the activities of KVN;
- 4.4.5 freely leave the KVN membership based on your own desire;
- 4.4.6 elect and be elected to the KVN coordination bodies.

4.5 KVN members are obliged to:

- 4.5.1 know these Regulations:
- 4.5.2 act in accordance with the goals and main objectives of KVN activities;
- 4.5.3 take an active part in the work of KVN, planning and conducting events:
- 4.5.4 carry out all decisions of the general meeting of KVN members:
- 4.5.5 comply with the requirements of this Regulation and the obligations undertaken;
- 4.5.6 attend meetings of KVN members in a timely manner;
- 4.5.7 be a model for others, lead a healthy lifestyle, do good to people, always be ready to help;
- 4.5.8 be responsible for your behavior and actions:
- 4.5.9 not to commit actions that violate these Regulations, the ethics of friendly relationships, as well as actions that cause moral or material damage to KVN, refrain from activities that contradict the goals and objectives of KVN;
- 4.5.10 protect your good name and dignity of KVN.

5. Management of activities and structure of KVN

- 5.1 The governing body of KVN is a youth organization Academies;
- 5.2 The activities of KVN are organized by its director, who is appointed for a period of 1 year.
- 5.3 The powers of the head of KVN extend to:
- 5.3.1 holding meetings of the general meeting of KVN members;
- 5.3.2 representing the interests of KVN in the youth organization of the university and the administration of the university, as well as before the leadership of various institutions, clubs, associations, etc.

5.4 The powers of the general meeting extend to:

5.4.1 determination of the KVN development strategy;

5.4.2 determination of areas of activity;

5.5 The general meeting is held at least once a month. Optional half of the KVN members, or at the request of the governing body Extraordinary sessions and meetings may be held.
